## **ICAC INVESTIGATIVE STANDARDS**

When doing ICAC investigations:


- Have a copy of the ICAC standards and have read them
- Authority of what you do is up to your ICAC Commander and local/federal prosecutor
- Follow all local, state and federal laws
- Non-sworn can conduct ICAC investigations only when under direct supervision of a sworn law enforcement officer
- ICAC does not allow us to cooperate with cyber vigilant groups
- . When doing investigations, we must document our investigative work
- When doing online undercover investigations, the investigator must let the suspect set the tone, pace and subject matter of the investigation



### **ICAC INVESTIGATIVE STANDARDS**

Undercover Photographs

- . When using a photograph to represent yourself online, it has to be of a real person
- That person must be a current member of law enforcement
- The person providing the images has to sign a consent form and must be 18 years or older when signing the form
- •The images used may be of the employee when that employee was a juvenile

UC agents may properly make use of false names

never be detected without the use of such undercover techniques.




